2. Matters Arising

7. Capel Cana Cemetery

A letter has been received, noting the sum of £10k, circulated before the meeting. Discuss that this is a large commitment in the long term, hard to work out which costs will arise. Is the amount enough – costs increasing, so ask if there is more? The money will be ringfenced. Will we need a separate account? Possible to use the reserve account? A sense that a separate account would be a good idea. AGREE to open a new account – with someone who offers better terms?

8. Wifi in Yr Efail

In place. Need an arrangement about sharing the password, safety, more control over this. These are things to note since this is only for 6 months. Contact Ceri to ask if anybody is

monitoring the use. It would be good to have a system in place where someone has to enter their email address and say where they are from, in the long term.

9. Ministerial Review of Play

Key Recommendation 9, point 3

Dawn has considered the report in some detail, and this recommendation is relevant: need to contact young ambassadors from the community and plan according to their suggestions. Suggest contacting the School Council. Need to keep a record of this. Dawn willing to go to the school and get feedback, starting at Parc y Bont. This is for all sorts of play, and the youngest children are suffering. A lack for the teenagers too.

In terms of the playground, no developments, but serious problems with the fence, and it needs to be sorted. Waiting for a response from Gethin Morgan. The fence is a safety issue: give the council a week to fix it, and if they do not, get the work done and send the bill. AGREE to do this work if the council don't do it.

Drainage in the field has not worked at all. A large mound of earth the other side of the playground fence is preventing the water from draining there. If it would be possible to get someone there, this could sort the problem. Wait for feedback.

10. Path No 2

A problem with the stile. Suggested bypassing it but Arwel notes that this is the landowners' responsibility. Need to make them aware of their responsibility. Need to contact the landowners about the stile. Clerk to contact.

11. Road Safety – Update

The new street lamp has been discussed with the Council. Margaret wrote a response to the Council, sent on 22 February, but need to enquire whether they received this response.

12. Report of Any Meetings

School Governors: in the process of appointing a new head. Things will be clear by the next meeting.

13. County Councillors' Report

The budget has been set – and it has been agreed that the Council has a 5 year plan, with much more response than usual to the consultation. This will be reviewed every year. The plan has been decided, now need to deliver this. Some councillors have changed their roles. Changes happening within the Council.
